Thank you for your interest in the 2020 Lake Mills Fall Festival of Color. Each year during our Fall Festival of Color, historic Commons Park in downtown Lake Mills is full of artists, crafters, local produce and fall flower vendors. It's truly a family event--local food vendors, pumpkin decorating, kid's events, and live music performed in the restored gazebo add to the festivities and contribute to heavy shopping traffic for our vendors all day.

To be accepted to Fall Festival, the Lake Mills Chamber of Commerce must receive a completed application, complete WI DOR Temporary Sellers Form (S-240), and payment of \$45 in the form of check or money order.

### **Rules for the day of the event:**

- Set up is from 7-9 AM. Booths may not be set up the night before.
- Booths must be set up at least three feet back (to allow better traffic flow on the sidewalk) and facing the sidewalk.
- Vendors may park near their booth to unload. Vehicles **MUST** be moved immediately after unloading and no later than 8:45 AM to provide adequate customer parking. Vendor parking is available in designated locations. Failure to remove your vehicle from the square will result in one warning. If you do not comply you may be asked to leave the event with no refund.
- Early breakdown of your booth before 3 PM is highly discouraged and can lead to not being invited back.
- Each booth space is 10x10. Booth numbers and location will be emailed 1 week prior to the event.
- Refunds are not given
- Vendor spaces are non-transferable
- After the event, your vendor spot must be cleaned, taking waste with you. You may not leave cardboard boxes (even in broken down).
- Refunds will not be given for rain or inclement weather.
- Checks returned NSF will be assessed a \$25 returned check fee by the Lake Mills Chamber of Commerce.

Signing the Fall Festival application form indicates you have read and will abide by these event rules.
